AUDITION REQUIREMENTS

ColOrchestra, a partnership initiative between /kor/ productions, Progressive Musicians, Sound Espresso, Artistventure Concerts and Virtual Concert Halls are looking for soloists for engagements in 2023-2024 concert seasons with **Cairo Opera Orchestra in Cairo, Egypt**.

This engagement is based on the of *Ensemble Concertos*, which means the concert program will consist on Double, Triple concertos or combinations of it and one of the soloists will be a member of the Cairo Opera Orchestra, while the other soloist will be selected during the Auditions. **The concert date is April 30, 2024.**

Audition is open for the following instruments/voices:

- Piano
- Violin
- Viola
- Cello
- Double bass
- Guitar
- Harp
- Flute
- Oboe/Corno Inglese
- Clarinet
- Saxophone
- Bassoon/Contrabassoon
- French horn
- Trumpet
- Trombone
- Tuba
- Percussion
- Bass

APPLICATION DEADLINES and important dates:

- November 15, 2023 - Deadline to apply with a video of your choosing
- December 30, 2023 - Deadline to register for LIVE Audition (for those who are invited based on their video submission)
- January, 2024 (dates TBA) - Streaming technology seminar in preparation for your Live Audition
- January 26-29, 2024 - Live Auditions. Broadcast on video and social platforms. Meet the Judges and the Music Director.
- April 26-29, 2024 - Rehearsals
- April 30, 2024 - Concert

GENERAL RULES

- Incomplete applications (including failure to pay the application fee) will not be processed
- Application fee is non-refundable
- Decisions on selections are final and cannot be appealed. However, a commentary on your performance from the artistic committee may be provided upon request (in English language only).

VIDEO MATERIAL for Pre-screening Round

Auditionees are required to submit a video recording for the audition. Recordings should be a fair representation of your abilities but do not need to be of a professional quality. Auditionees must submit either one or two video recordings.

The repertoire choice is free; with no time limit.

Accompaniment

Auditionees will not be discriminated against for their choice of accompaniment (live piano accompaniment, track, or no accompaniment)

Auditionees who do not advance to the Live Audition round will receive comments from the Judges and Certificates of Participation

Final Round of the Auditions via Live Stream

Auditionees prepare a piece or a movement from the repertoire list (see Sample Concertos)

- If you audition with a movement of a Concerto, prepare up to 15 minutes
- If you audition with a full Concerto, prepare material from each movement (up to 30 minutes total)

FINAL OUTCOME

A selected group of performers will receive an invitation to perform with Cairo Opera Orchestra in the capacity of a soloist.

THE ARTISTIC COMMITTEE

The Artistic Committee evaluates the video material submitted, and the final selections of winners are based on the same recordings submitted.

APPLICATION REQUIREMENTS

- Up to two video recordings uploaded online (YouTube or other video platform)
- Preliminary Audition fee - \$50 USD
- Final Audition fee (only for those who pass Preliminary Audition) - \$200 USD

MISCELLANEOUS

- Organizers reserve the right to make any changes in the rules, schedule and other information related to the award
- Underage* auditionees shall be under the responsibility of their parents or legal guardians. They must be supervised at all times by their parents or legal guardians.
*LEGAL AGE IS DETERMINED ACCORDING TO LOCAL LAWS AND REGULATIONS OF THE COUNTRY OR JURISDICTION OF AUDITIONEES' PRIMARY RESIDENCE
- Organizers are not responsible for any damage or theft of instruments or personal belongings of participants.
- Auditionees agree and authorize the organizers of the concert to use their image for any publicity and activity related to the event.
- Auditionees are required to provide a high-resolution photo for the publicity purposes
- Auditionees waive all rights to television broadcasting remuneration. There will be no financial remuneration for their performance.
- All auditionees are responsible for their own expenses (travel, accommodations, accompanists, etc)
- The official language of the audition is English.
